Contributions to Relentless Positive Action PAC are not deductible as charitable contributions for federal income tax purposes. Contributions from foreign nationals are prohibited. Relentless Positive Action PAC is registered with the Federal Election Commission as both an independent expenditure-only committee, and as a non-connected committee. As such, it maintains two separate bank accounts: (1) a federal non-contribution account for independent expenditures; and (2) a federal "hard money" contribution account. Relentless Positive Action PAC may accept unlimited contributions from individuals, corporations, and other organizations into its federal non-contribution account. Relentless Positive Action PAC may not accept contributions from corporations, labor organizations, federal government contractors, national banks, and foreign nationals into the federal "hard money" contribution account. The maximum an individual may contribute to Relentless Positive Action PAC's federal "hard money" contribution account is \$5,000 per calendar year.
